- c) The candidates will initially be positioned at MUMBAI till they obtain sufficient experience and will be posted either at Mumbai or at any outstation of Boeing group as per the requirement of the Company. The job is transferable to any station in India, based on Company's requirement.
- d) The candidates will have to make their own arrangement for housing accommodation at the place of posting.
- e) The Company, at its discretion, may assign additional duties, as and when required.

Candidates are advised to go through the following instructions before Appearing for Interview

- a) A recent (not more than three months old) colored passport-size photograph of the full face (Front view) should be pasted neatly in the space provided in the Application form, and also to be uploaded while filling up the online application form. Original hard copy of filled application form should be submitted to us at the time of personal interview.
- b) The candidates belonging to OBC categories, at the time of interview, must submit a self-attested photocopy of the “Non-Creamy Layer” Certificate, recently issued by the Competent Authority, in the format as prescribed by Govt. of India. The Certificate, inter alia, must specifically state that the candidate does not belong to socially advanced sections excluded from the benefits of reservations for OBC in civil posts and services under the Government of India. The Certificate should also contain the “Non-Creamy Layer” Clause. The Certificate produced by the candidates of OBC community should be as per the Central List published by the Government of India and not as per the State Lists.
- c) Applicants ordinarily domiciled in Kashmir Division of J & K State during 01.01.1980 to 31.12.1989 who are eligible for the upper age relaxation, must produce the Domicile Certificate to this effect at the time of Interview from the District Magistrate in the Kashmir Division, within whose jurisdiction the applicant had ordinarily resided or any other authority designated in this regard by the Government of Jammu & Kashmir.
- d) The applicant should ensure that they fulfill all the eligibility criteria as on 01 January 2023. Other particulars furnished should be correct in all respects.
