5			Kindly clarify whether escalation in Minimum wages will be reimbursed by your good office or bidder need to consider the same while quoting the rates in his financial bid.	<ul> <li>Housekeeping &amp; Gardening Services are purely service based contract and no escalation in quoted rates will be entertained during the complete contract period. Hence, bidders need to consider in their quoted rates the payment of all statutory compliances (PF, ESIC, Bonus, etc.) and escalation of wages (as per the minimum wages defined by Maharashtra Govt. for workers engaged in Engineering Industries).</li> <li>For Manpower Supply Services (i.e., Driver, Asst. Storekeeper, Handymen), the contract is on manpower basis and wages paid to employees working under Manpower Supply Services will be completely reimbursed by AIESL as per the minimum wages defined by Maharashtra Govt. for personnel engaged in Engineering Industries. However, bidders are not required to consider payment of bonus while quoting monthly CTC of workers deployed under Manpower Supply Services. Bonus paid to their employees by the service provider will be reimbursed by AIESL after the receipt of proof of payment and commercially clear invoice.</li> </ul>

			It is requested that the Security Deposit / Performance Bank Guarantee should be calculated based on the annual value of contract instead of total contract value (for the period of 02 years).	
8	Pg. no. 66. Clause 17.1	-	For levying any fine, what are the criteria to decide whether the quality of cleaning is satisfactory or unsatisfactory?	Quality of cleaning will be decided based on the quality standards mentioned in pg. no. 33 and the minimum frequencies of cleaning mentioned in the pg. no. 34- 42 in the "Scope of Work" of the Tender Document (MRO/NAG/ADMIN /2024/046 Dtd. 09.05.2024)
9	-	Pg. no. 1	As mentioned in the GeM bid document that the experience criteria & the criteria of minimum average annual turnover for MSEs are exempted. Kindly clarify up to what extents these criteria are exempted for MSEs.	There will be "no relaxation or exemption" in the experience criteria & the criteria of minimum average annual turnover for bidders (including MSEs & Start-ups).
10	Pg no. 24	-	Kindly review the requirement of Solvency certificate mentioned in the Sub-Point no. 17 of Point no. II of "Checklist of Technical Bid" as: "Recent solvency certificate from Nationalized / Scheduled bank of value at least Rs. 1.0 Crore (Rupees One Crore) duly certified by a Chartered Account (Enrolled with ICAI)."	The Bidder has to furnish a Solvency certificate from Nationalised / Schedule Bank of value at least Rs. 2,08, 87,439/- (Rupees Two Crores Eight Lakhs Eighty Seven Thousands Four hundred and thirty Nine) i.e., 40% of the Estimated Contract Value, duly certified by a Chartered Account (Enrolled with ICAI), with the specific period of validity mentioned.

11	Pg. no. 47 & 48	-	In the Tender Document, Handymen are categorized under Unskilled category but in the job description of Handymen some works (like operating Forklift) defined are done by skilled manpower and hence handymen should be considered under semi-skilled or Skilled category.	Under the job description of handymen in Tender Document(MRO/ NAG / ADMIN /2024/046 Dtd. 09.05.2024), in Pg. no.47 & 48, it is mentioned that "Operating/Driving ground support vehicles like Platform truck, scissor Lift, Tow truck & Fork Lift for carrying various items as per the directions of reporting In-charge" In the above statement, requirement of operating forklifts by the handymen is <b>removed</b> .
12	Pg. no. 47 & 48	-	Age criteria mentioned for Driver, Handymen, and Asst. Storekeepers, are very restrictive. Request you to consider the upper age limit of manpower to be deployed as 50 yrs.	No change and as per the terms of Tender document (MRO/ NAG / ADMIN /2024/046 Dtd. 09.05.2024).
13	-	Pg. no. 7, 9, 11	Request you to provide calculation /formula used for calculation of various components of wages given in GeM Bid document for different categories of workers.	Detailed calculation is enclosed in Appendix I.
