Tenders under SINGLE STAGE, TWO-BID system (Technical bid & Price bid) are invited on GeM (Government e-Marketplace) from **interested Hotels located in Nagpur having good reputation and decent ratings**, for providing hotel accommodation to officials visiting AIESL Nagpur MRO. This tender enquiry comprises following:

- 1. **Contract Period:** The contract shall be for a period of **two years**. The estimated no. of room booking on 24 hrs chk in/ chk out basis, needed shall be approx. 200 nos. annually. Numbers of bookings may increase or decrease as per AIESL requirement and billing will be on actual basis. The contract could be extended for a period of **one year** at the same rates, terms & conditions if mutually agreed.
- 2. While there is no fixed requirement of rooms, AIESL is required to enter into a rate contract with a suitable hotel to accommodate the staff deputed to Nagpur on duty.
- 3. AIESL shall have right to reject/ eliminate the offers which are not conforming to the selection criteria.

General Terms and Conditions for the Hotel Accommodation rate Contract (To be uploaded in Technical Bid, duly signed and stamped on all pages, as token of acceptance)

- **1.** "AIESL" as used in the tender document means "AI ENGINEERING SERVICES LTD."
- 2. The hotel rating should be 3 star and above.
- **3.** All hoteliers shall give an undertaking to abide by terms and conditions as per the requirement and agreed too.
- 4. Bid Security / Earnest Money Deposit: EMD is not applicable
- 5. Security Deposit/Performance Guarantee: Not Applicable
- 6. Turnover Criteria: Not Applicable
- 7. MSME/MSE/Start-ups unit will get preference as per GOI guideline.
- **8. Award of Contract**: On the basis of the report of the committee, the hotels will be shortlisted and Price Bids of only shortlisted Bidders shall be opened to identify the lowest rates offered in each category of hotel (3, 4 & 5 star). The bidder quoting the lowest rates in their respective category (i.e., 3, 4, or 5 star) will be declared as the successful bidder for that particular category (i.e., 3, 4, or 5 star).

However, to ensure availability of rooms during peak seasons, AIESL may consider empaneling more than one hotel of particular category (i.e., 3, 4, or 5 star) at L-1 price of that particular category (i.e., 3, 4, or 5 star). In this case, splitting of requirement will be done on the basis of "differential rates quoted by the tenderer" as mentioned below:

In the phrase "differential rates quoted by the tenderers", the quoted rate would mean

- a. When no price negotiation has been called for, the original rates as obtained at the time of tender opening.
- b. When price negotiation has been called for, the reference L1 rate for assessment of ratio will be the original rate of L1 firm as obtained at the time of tender opening.
- **9.** The Hotel is required to bid for the room requirement. AIESL at its discretion shall enter into contract with the hotel depending upon the various factors such as proximity, availability of rooms and facilities provided by each hotel.
- **10.** AIESL shall be billed on the actual rooms utilized. No overlapping charges would be applicable for a check out exceeding agreed check out time, by up to 4 hrs due to flight delays / exigencies etc.
- **11. Room charges (Bed & Breakfast Basis)**: The quotes for the room shall be on bed & breakfast basis & shall clearly specify the details giving break-up for the room charges and applicable IGST, (% of tax applicable on quoted rates) as per the Price Bid format Annexure 3.

## 12. (A) Facilities required without any additional payment, and covered within the quoted room rates.

- ii. STD/ISD calls

#### 13. Exit Clause:

- a) The agreement can be terminated with 60 days' notice by either party, without assigning any reason. However, AIESL will be free to terminate the contract by giving notice for a lesser period due to unsatisfactory services or complaints received from the staff without any liability to AIESL.
- b) Unless both the parties mutually agree for an extension, the contract stands automatically terminated on its expiry date and no notice of termination will be required.
- **14. GST**: The rates quoted in the commercial bid shall be on bed and breakfast basis inclusive of GST. However, the tender shall indicate the rate of GST applicable as on the due date of the tender. In case of any change in the GST affected by the Govt., during the contract period, the same shall be paid by AIESL at actual on production of Govt. Notification.
- **15. Terms of Payment**: Bills for actual occupancy to be raised on monthly basis on AIESL and submitted to General Manager Engg, AIESL MRO for certification of occupancy along with the authorization. Bills without supporting authorization and guest signature shall not be processed. Bills will be paid within 45-60 days of the date of receipt of the commercially clear invoices.
- **16.** Payment will be made through ECS (Electronic Clearance Service), TDS shall be deducted by AIESL from the payment made against these invoices, as per the applicable laws.
- **17. Cancellation Charges**: Cancellation Charges for Room booking shall not be applicable.
- **18. Rooms' availability:** In the event of non-availability of rooms of the category of room contracted for, then the officials shall be accommodated in a higher category room without any additional charges. In the event of no substitute higher category room being available for whatsoever reason, alternate accommodation is to be arranged by the Hotel in other Hotels / Rooms of a comparable standard, with pre-approval of AIESL.

- **21.Site Visit:** AIESL reserves the right to conduct a site visit of the property by the tender committee member/s or by their authorized representative for the purpose of confirming the services provided and assessing the quality of services, so as to ensure conformity with the legal specifications quoted in the tender.
- **22.** AIESL reserves the right to reject all or any of the Tenders at any stage without assigning any reasons whatsoever and the decision of AIESL in the matter shall be final and binding on the parties.
- **23.** The prospective tenderers should have the compliance of all the relevant Laws, Acts and regulations as applicable from time to time.
- **24.** Any deviation in submitting the tenders as prescribed or any incomplete tenders are liable for **rejection**. Quotes shall be submitted in the Price Bid format both in words and figures. In case of any variation or correction, the quote given in words shall be taken for evaluation and award of contract.
- **25.** Your offer shall also be **rejected** in case of the following:-
  - Only single bid i.e. only Technical or only Price bid received.
  - Quotation received by fax / email.
  - Quotation received unsigned.
- 26. Amendments and clarifications, if any, to this tender will be published on GeM. The last amendment, if any, will be hosted a minimum of seven days before the closing date of the tender.
- **27. Interpretation:** In the event of any difference in the interpretation of any of the clauses of the Agreement and/or the Tender documents, the clarification given by GM-Engg, AIESL, MRO Nagpur, shall be final and binding.
