General Terms and conditions:

1. AIESL as used in the tender document means 'AI Engineering Services Limited'.
2. Purchase Order means the order issued or the Contract signed between 'AI Engineering Services Limited' and the successful Bidder/Tenderer/Service Provider for supply of subject item(s).
3. The "Tenderer" and/or "Party", as used in the tender document, shall mean the one who has signed the tender form and submitted the quotation in response to the tender. The Tenderer should be Manufacturer/Distributor/Stockiest/Dealer for supply of the subject tendered items. In the event the Bidder / Tenderer / Service Provider are bidding against this tender as a Distributor / Stockiest / Dealer for supply of the subject tendered item, they are required to submit the authorization certificate from manufacturer for the sale and supply of the items manufactured by them.
4. It is further clarified that any individual signing the tender or other documents in connection with the tender must certify whether he signs as:
 - A " Sole Proprietor "of the firm or constituted attorney of such sole proprietor.
 - A partner of the firm if it is a partnership firm and must have authority to refer to arbitration, disputes concerning the business of the partnership either by virtue of the partnership agreement or a power of attorney. In the alternative, the Tender should be signed by all the Partners.
 - Constituted attorney of the firm, if it is a Company.
 - Authorized signatory of the firm.
5. Ineligible/Technically rejected Bidder's application shall not be entertained for Financial Bid opening and the decision of AI Engineering Services Limited in this regard would be final. No correspondence in this regard will be entertained. **Offers should be valid for AI Engineering Services Limited's acceptance for a period of 75 days from the date of opening of the Technical Bid (Pre-qualification Bid) Part- A**
6. The Tenderers are required to submit Technical Bid (Pre-Qualification Bid) and Financial Bid in separate envelopes and both these envelopes are to be closed/sealed in third master envelope, as indicated in the cover sheet of this tender.
7. Tenders should be filled in prescribed forms duly signed and stamped and all prices be clearly written/typed both in words and figures without any overwriting. Corrections & overwriting, if any, should be counter signed by the tenderer. The amounts quoted by the tenderers/ bidders for the Financial Bid, as specified in Annexure "D" shall be stated both in figures (English Numerals) and words. In case of any discrepancy, the amount written in words shall be considered as final for the purpose of evaluation of the Financial Bid.
8. **Sealed / Closed tender documents are to be deposited / delivered in the tender box earmarked for this purpose in the Purchase Section, EPPMM Department, AI ENGINEERING SERVICES LTD, MRO Complex, Near Gate 03, RGI Airport, and Shamshabad.** The tender documents sent through post or courier will be at the risk of the tenderer and AIESL will not be responsible for any loss or non-receipt of the tender documents. 9. Tenderers are advised to study the tender document carefully. Submission of tender shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.
 10. Bids should be unconditional. Conditional bids would not be accepted and are liable to be rejected.
 11. The tender and resultant contract is CONFIDENTIAL, and anything contained in this document shall not be disclosed in any manner, whatsoever. The undue use of the confidential contents of this tender and the information contained therein, if observed or proven may result in the rejection of bid/ contract ipso facto.
 12. Tenderer shall give the official mailing address and email ID, fax numbers to which all correspondences shall be sent by AIESL. Also, if address is changed, the same shall be intimated to AIESL immediately.
 13. When deemed necessary, AIESL may seek clarifications on any aspect from the tenderer.
 14. AI engineering Services Ltd reserves the right to accept or reject any/ or all bids, annul the tender process and reject any or all the bids at any time prior to the award of contract without incurring any liability to the affected bidder(s)/ tenderer(s) or without any obligation to inform the affected bidder(s)/ tenderer(s) on the grounds of such annulment/rejection.  16. In the event of default in supply, AIESL reserves the right to cancel the order and to claim damages from the successful tenderer, and also reserves the right to award the contract to another vendor at the cost and risk of the successful tenderer.
 17. The documents enclosed in Envelope 1 should not contain any indication of the price. In case an indication of the price quoted is included in the documents enclosed in Envelope 1, the quotation will be out rightly rejected without any reference to the tenderer. No correspondence will be entertained in this regard.
 18. On the due date of opening of the bids, the Envelope 1- Technical Bid (Pre-qualification Bid) containing the "Letter of Acceptance of all the Terms and Conditions of the Tender" and a copy of Blank Financial Bid format duly crossed and signed by the tenderer, will be opened first. If the tenderer / bidder is seen to have confirmed acceptance of all the Terms and Conditions of the tender, as a part of the Technical Bid will be considered for further technical evaluation and subsequent opening of the Financial bids for all of those bidders / tenderers who have qualified in the technical evaluation exercise. AI Engineering Services Limited shall invite the short-listed tenderers to be present during the opening of the Financial Bids for which the date, time and venue of tender opening will be advised in advance. 19. Benefits/Preference for Micro & Small Enterprises (MSEs):

As per Public Procurement Policy for Micro & Small Enterprises (MSEs) Order, 2012 issued vide Gazette Notification No.503 dated 23.03.2012 by Ministry of Micro, Small and Medium Enterprises of Government of India, MSEs must be registered with any of the following in order to avail the benefits/preference available vide Public Procurement Policy MSEs Order, 2012.

- District Industries Centers (DIC)
- Khadi and Village Industries Commission(KVIC)
- Khadi and Village Industries Board
- Coir Board
- National Small Industries Corporation(NSIC)
- Directorate of Handicraft and Handloom
- Any other body specified by Ministry of MSME

- a) MSEs participating in the tender must submit the certificate of registration with any one of the above agencies indicating the details of the particular tendered item along with their bid.
- b) The MSEs registered with District Industries Centers must submit the 'Acknowledgement of Entrepreneur Memorandum (EM) Part-II' along with their bid. The MSEs registered with National Small Industries Corporation (NSIC) must submit the valid NSIC registration certificate along with their bid.
- c) The Micro & Small Enterprises not registered for the particular trade/item for which the tender is relevant, would not be eligible for exemption/preference.
- d) The registration certificate issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.

20. Security Deposit

- a) The tenderer who qualifies for award of Purchase Order will have to deposit with AIESL 3% of the total value of the Purchase Order towards **interest free Security Deposit**, within 2 weeks of receipt of the Purchase Order. The Security Deposit is to be paid by a Bank Draft or a Banker's Cheque in favour of the 'AI Engineering Services Ltd, payable at Hyderabad, or by execution of a Bank Guarantee for an equivalent amount. The expenses incurred towards submission of Security Deposit / Bank Guarantee will have to be borne by the tenderer.
- b) The validity of Security Deposit / Bank Guarantee should be till 30 days after the schedule completion to all obligations under the purchase order / contract.
- c) The Security Deposit/Bank Guarantee will be refunded / returned after the completion of contract after adjusting for penalties, if any, that may be imposed under the terms of the Purchase Order.
- d) In case, Security Deposit is not deposited in time, the bills shall not be processed for payment. In exceptional case, if the shortlisted tenderer desires, the Security Deposit amount can be deducted from the shortlisted tenderers' bills and the balance payment released, for which the vendor will have to give a specific request to our Finance Department.

21. Recovery of sum due:

- a) Whenever under the Purchase Order/Agreement any sum of money is recoverable from the vendor, AIESL shall be entitled to recover such sum from payments due by AIESL to the vendor or by appropriating in part or full from the security deposit already deposited by the vendor.
22. In the event of the said payment due to by AIESL to the tenderer being in-sufficient and also Security Deposit being insufficient, the balance or the total amount recoverable, as the case may be, shall be deducted from any other sum due to the vendor, under this, or any other Order/Agreement between the vendor and AIESL. Should this amount be insufficient to cover the said full amount recoverable, the vendor shall pay to AIESL the balance amount, if any, within 30 days of the demand by AIESL.

23. Payment Terms:

Payment will be made within 45 -60 days from the date of receipt of the materials/ Original invoice, whichever is later. Requests if any, for an earlier payment term, either advance payments or payment against delivery, will not be entertained under any circumstances.

24. Penalty Clause and Liquidated Damages:

- a) In case of delay in delivery, liquidated damages will be charged from the defaulting contractor at the rate of 0.5% (half percent) per week or part thereof of the value of delayed supplies(excluding the taxes and delivery charges), subject to a maximum of 10% (ten percent) of the value of the delayed supplies. In case of non-supply of tendered item(s) AIESL reserves the right to arrange their requirements from alternate source. In such a situation, difference in price shall be recovered from the tenderer's running bills/ Security Deposit. It must be noted that the limit of 10% will not be applicable in case of Risk Purchase.
- b) AIESL reserves the right to cancel the Purchase Order in the event of delayed deliveries, and to issue a fresh Purchase Order on any other source at the risk and cost of the tenderer who has been awarded the contract.
- c) Penalty for Substandard Quality: After the acceptance of delivery at our Stores , in case of any complaint received, at the time of usage of tendered item(s)or regarding poor quality of tendered item(s)then AIESL reserves the right to deduct the complete cost of the batch supplied and if the complaint continues to persist and if AIESL is convinced that there is no intention of remedial action at the suppliers' end, then receipts /acceptance of supplies will be stopped for with, PO will be cancelled and penalty action will be taken at the sole discretion of AIESL, including forfeiting of the Security Deposit.
- d) Rejection: If supplies are found to be defective or not conforming to the specifications/requirements, it may result in rejection of the entire supply without any liability on 'AI Engineering Services Ltd.', and a fresh supply will have to be made IMMEDIATELY, FREE OF COST in order to sustain the requirements of AIESL.

25. **Price Negotiation:**

As it is not the general norm for AIESL to carry out price negotiations following evaluation of the Financial bids, the tenderers are advised to submit their best quotes in response to this tender. AIESL, however, reserves the right to carry out negotiations in exceptional cases with the tenderer(s) who have been evaluated by AIESL as having offered the lowest bid in response to the tender.

26. **Validity of Rates:**

- a) Quotations should be valid for a period of 30 days from the date of opening of Technical Bid (Pre-Qualification Bid) –Part A.
- b) The quoted rates which have been agreed and approved by AIESL should remain firm for the complete supplies during the contract period.
- c) The price offered/finalized should remain firm till completion of the delivery of the quantity as ordered. No request for increase in price shall be entertained during this period except on account of increase in statutory duties, taxes, etc., if imposed by the Govt. of India.
- d) The tenderers should commit to pass on the benefit to AIESL of reduction in statutory duties, taxes, etc, by the Government, during the period of validity of the Purchase Order.

27. **REJECTION OF BIDS:** Your Bid will be rejected on the following grounds:

- Bid received after due date.
- Only "Financial Bid" received without the "Pre-Qualification Bid" (Technical Bid) and vice-versa.
- If the Pre-qualification (technical Bid) and/or the Financial Bid have been received by fax or email.
- If the Pre-qualification (Technical Bid) and/or the Financial Bid has been received unsigned.
- Bid not received in separate sealed/closed envelopes.
- Any deviation in submitting the Bid as prescribed or incomplete Bid or the Bid received in an Open condition.
- If the 'Financial Bid' is not as per the Format given at Annexure 'D'.
- If the samples of the tendered item of submitted by the tender along with the bid are not found suitable.
- Conditional "Pre-qualification Bid" (Technical Bid) is liable for rejection. Decision of AIESL in such case shall be final and binding.

28. EVALUATION CRITERIA:

A. Pre-qualification Bids (Technical Bid):

The Technical Bids (Pre-qualification Bids) would be first evaluated for compliance. AI Engineering Services Ltd reserves the right at its sole discretion to seek whatever information, documents etc. from the tenderer as it may consider necessary for the purpose of evaluation of the technical bids.

B. Financial Bids:

The Financial Bids of only those tenderers who qualify in the "Technical Bid / Pre-qualification Bid" and also comply with the other requirements as specified in the tender would be opened. The date and time of opening of the Financial Bids would be intimated in advance to the tenderers who have qualified in the "Technical Bid / Pre-qualification Bid" evaluation and their authorized representatives only would be permitted to participate in the opening of the Financial Bids.

The Financial Bids should be submitted strictly as per the format given at Annexure 'D' only. The detailed procedure/ method of quoting and criteria for evaluation of the Financial Bids has been explained in Annexure 'D' itself.

29. Evaluation of Bids/Queries from the bidders:

During the process of the evaluation of bids, no queries shall be entertained from the bidders with regard to the status of the evaluation.

30. Disqualified Bids:

- a) Financial bids of the "Technical Bid / Pre-qualification Bid" disqualified bidders would be returned to them after finalization of the contract under intimation and against acknowledgement from the bidders, in sealed condition itself.
- b) In case a bidder fails to collect the financial bid within the stipulated 30 days' time, the bid shall be shredded in "as is where is" condition after expiry of 30 days' time.

31. Extension of due date:

The Due date of tender may be extended at any time prior to the date of closing of the tender. Also closing date for submission of bids may be extended at any time including after the scheduled date of closing, at the sole discretion of AIESL.

32. Other Terms & Conditions:

Interpretation: In the event of any difference in the interpretation of any of the clauses of the Purchase Order/Agreement and/ or the tender documents, the clarification given by Dy. General Manager (E-PPMM), AIESL, Hyderabad, shall be final and binding.

33. Arbitration:

- a) Any dispute arising between the parties in respect of the construction, interpretation, application, meaning, scope, operation or effect of the contract or the validity or breach thereof, shall first be settled by mutual consultation.

- b) If the dispute remains unresolved after a period of 90 days from the date when the mutual consultation has started, then the unresolved dispute/difference shall be settled by arbitration in accordance with Arbitration and conciliation Act, 1996, and the award made in pursuance thereof shall be final and binding on the parties. The arbitral tribunal shall consist of a sole arbitrator to be mutually appointed by the parties.
- c) The place of Arbitration shall be Hyderabad, India.
- d) The cost of arbitration shall be borne by the parties as per directions of the presiding arbitrator.
- e) The venue of arbitration shall be Hyderabad and the arbitration proceedings shall be carried out in English.

34. Jurisdiction:

Any dispute whatsoever shall be subject to the jurisdiction of the courts of Hyderabad only.

35. Deviation:

Any deviation from our requirement or non-acceptance of any terms of the tender must be clearly spelt out and AIESL will decide on acceptance or rejection of any such deviation in the terms of the tender & decision of AI Engineering Services Ltd in such case will be final and binding.
