1. INTRODUCTION

Al Engineering Services Limited (AIESL), Ex-subsidiary of Air India Ltd., having MRO capabilities for Boeing and Airbus aircraft, associated engines, APUs and components (please refer AIESL website https://www.aiesl.in/AircraftCapability.aspx intends to appoint a Consultant/Agency to market AIESL's MRO Services as per the terms and conditions specified in this tender.

2. INSTRUCTIONS FOR BIDDING

- **2.1.** The Bids should be neatly presented. Corrections, if any, should be duly authenticated with full signature of the person who has signed the Bids, failing which such Bids shall be rejected.
- **2.2.** Before submitting the bid, the Bidders are requested to carefully examine the Tender Documents, Terms & Conditions of Assignment, Specifications. If there should be or appear to be any ambiguity there-in they should immediately refer the matter to Al Engineering Services Ltd., for clarification.
- **2.3.** The Bidder shall complete the annexed forms of Tender with information called for therein, and shall initial with date on each page of the Tender Document.
- **2.4.** Bids must be submitted in sealed Envelope only in person or by courier. Bids received by Fax shall be rejected.
- **2.5.** The bid should be accompanied by the document proofs for qualifying requirements. Documents not required as part of the bid should not be provided.

Please do not include price & commercial terms in the technical bid.

4. CLARIFICATIONS:

5. OPENING OF BIDS:

Technical bids will be opened on **20th January 2023 at 1630 Hrs. IST** in the office of Industrial Engineering, 4th Floor, Hangar No, 3, Old airport, Kalina, Santacruz (East), Mumbai-400029. The bidders or their authorized person, if so desirous, can be present at the opening of the technical bid with prior information. The bidders may join the opening of the technical bids through VC (Video Conferencing). The link will be sent to interested bidders provided they should sent an email request for the same to mukesh.kumar@aiesl.in & sales.aiesl@aiesl.in.

The date and time of the opening of Price bid of the technically qualified bidders will be communicated to the short-listed bidders. The bidders are requested to be in readiness to attend the opening of the Price bid at short notice.

ANNEXURE-1

TERMS & CONDITIONS OF THE TENDER

1. General terms:

- **1.1** Tenders received after the closing date & time will not be considered.
- 1.2 In case the Price bid and the Technical Bid are enclosed in the same envelope instead of in two separate sealed / closed envelopes and/or in an open condition, such Bids will be rejected.
- **1.3** The Bids should be neatly presented. Corrections, if any, should be duly authenticated with full signature of the person who has signed the Bids, failing which such Bids shall be rejected.
- 1.4 All bid documents as per attached annexure are to be submitted on bidder's company letterhead.
- **1.5** AIESL reserves the right to accept / reject any or all the offers submitted without assigning any reason whatsoever.
- 1.6 The Technical Bid should not contain any indication of price. In case, there is any indication of the price in the Technical Bid, such Bids will be rejected without any reference to the bidder. No correspondence will be entertained in this regard. However, a copy of price bid need to be put in technical bid envelope but the price quote should be masked so that the quote is not visible.
- 1.7 In case of any deviations/ variations from the terms and conditions of the tender, technical terms and commercial terms, the same must be clearly specified/ indicated in the technical bid only.
- **1.8** AIESL does not bind itself to accept the lowest or any bid and has the right to refuse any bid without assigning any reason. AIESL also has right to re-issue the Tender without Bidders having right to object to such reissue.
- **1.9** Amendments and clarifications, if any, to this tender, will be hosted on the website of AIESL at www.aiesl.in. The bidders are, therefore, advised to visit the websites regularly till the date of closing of the tender. The last amendment, if any, will be hosted a minimum of seven days before the closing date of the tender.
- 2. Tender Bond / Earnest Money Deposit (hereinafter referred to as "TB / EMD")
- 2.1 Bidders are required to submit a Tender Bond / Earnest Money Deposit of **USD 5000** (US Dollars Five Thousand Only). EMD must be submitted by the Bidder by means of Demand Draft in favour of Al Engineering Services Limited (AIESL). Tender Bond issued by any bank at Bangladesh must be claimed in India. **No other mode of payment is acceptable.**
- 2.2 In case of any query relating to wire transfer of the EMD, the bidders may contact rajendra.bhatia@aiesl.in
- **2.3** EMD will not carry any interest.
- **2.4** EMD of the unsuccessful bidders would be returned without any interest after award of contract to the successful bidder.
- 2.5 EMD / Tender Bond of the successful bidder may be returned after awarding of the contract. A Successful Bidder must submit BG USD 5000 which will be retained until completion of contract.



3. Agreement

- 3.1 The agreement will be finalized and signed with the selected bidder and fees finalised will be firm during the contract period.
- 3.2 The agreement will be valid for a period of three years and may be renewed for further period by two years on the same terms and conditions if mutually agreed by the parties.

4 Invoicing of Fees:

- **4.1** Fees will be paid in the same currency as applied by AIESL to its customers in AIESL invoices.
- **4.2** During the term of contract, the selected bidder is entitled to receive fees on the contracts/ orders concluded with customers brought by the selected bidder subject to the contract between AIESL and the customer is valid.
- a) If the contract between AIESL and the bidder is terminated for reasons stated in para 9.1 of this tender document, the selected bidder is entitled to receive bidder's fees for the work completed till the date of termination subjected to realization of payment from customers.
 - b) If the contract between AIESL and the bidder is terminated for reasons stated in para 9.2 of this tender document, the selected bidder is entitled to receive 75% fees subject to release of the payment by customers. 25% of bidder's fees will be deducted for not availing the services described in the scope of work in Annexure-2 of this tender document.
- **4.4** If the contract between AIESL and the selected bidder is terminated by the selected bidder, selected bidder will not be eligible for any fees although the contracts between customers and AIESL may remain in force.
- 4.5 No fees will be paid for any incidental and non-shop visit related material sales, lease charges, logistics and handling charges. No fees will be paid with respect to the procurement of any additional material billed to customer.

5. Payment of Fees:

- **5.1** Fees payment after deducting applicable taxes will be made within 30 days from the date of realization of the payments by Customer against AIESL invoices.
- **5.2** Invoicing address and the necessary contact references for payment will be notified in the contract.
- **5.3** Payment will be made through wire transfer. Full bank details such as name of Bank, Bank Account No. and currency, IBAN No. and Swift Code, details of routing bank if anywhere payment is to be affected should be furnished. AIESL will not accept payment terms of bank guarantee, letter of credit (LOC) and IATA clearance.
- 5.4 For spares supply business secured through the bidder, consultancy fees payment will be calculated based on CLP (Catalogue Listed Price) of the component only and will be paid after realization of payment by customer.

6. Penalty:

6.1 In the event of failure of successful bidder to achieve any revenue within 180 days from date of singing of the contract, the contract shall be reviewed for termination.



6.2 If the successful bidder is not able to achieve any revenue in the first year of contract, AIESL reserves full right to terminate the Contract.

7. Price negotiation

Generally, AIESL doesn't carry price negotiations following evaluation of the Price bids. Therefore, bidders are advised to submit their best quotes in response to this tender. Al Engineering Services Ltd. (AIESL) however, reserves the right to carry out negotiations as deemed fit.

8. Inspection:

Inspection of bidders' facilities at the time of evaluation of the Technical Bids: AIESL reserves the right to inspect at its cost the facility / facilities of the bidders in order to assess their infrastructure and capability for carrying on the contract as indicated in this tender.

9. Exit / Termination:

The Contract may be terminated under the following circumstances:

- **9.1** In the event of non-achievement of assured revenue target, bidder would be given an opportunity of 180 days to come up to the expectations of AIESL and his performance would be monitored. If the bidder is not able to perform in the said time frame, AIESL reserves full right to terminate the Contract.
- **9.2** If there is a change in AIESL's requirement, the Contract shall be terminated with 30 days advance notice as per the terms mentioned in para 4.3(b).
- 9.3 In the event of breach of any of terms of the contract, AIESL reserves the right to terminate the contract with 30 days' notice and to claim damages, if any, from the selected bidder. AIESL also reserves the right to award the contract to another agency at the cost and risk of the selected bidder.

10. Rejection of Bids (Technical bid & Price bid)

The response to the Technical Bid & Price bid will be rejected forthwith without evaluation of the tender response on the following grounds:

- i) If the Technical bid or the Price bid has been received after due date and time of closing of the tender.
- ii) If only the technical bid has been received and Price bid has not been received, and vice versa.
- iii) If the Technical bid or the Price bid has been received by Fax or If the technical or Price bid has been received by email without password protected attachment.
- iv) If the Technical bid or the Price bid has been received unsigned.
- v) If the Price bid has been received in an open condition in the master envelope containing the technical bid or if both the Technical bid & Price bid are received in an open condition in a single envelope.



11. Evaluation Criteria:

11.1 Technical Bid Evaluation:

The Technical Bids would be evaluated for their 'Compliance to the Technical Requirement' of the Tender as indicated at **Annexure 3 and Annexure 4.** Al Engineering Services Ltd. reserves the right at its sole discretion to seek whatever information, documents etc. from the bidder, as it may consider necessary for the purpose of evaluation of the bids.

Marks will be awarded on the basis of responses on para 5, 6 and 7 of technical bid as given in Annexure 3 and a comparison sheet will be prepared. These marks will be carried forward to the financial bid and the rates quoted will be divided by these marks of each participant. Example of the same is given below:

11.2 Price bid Evaluation:

- i. The Price bids of only those bidders who qualify and are shortlisted after evaluation of their Technical Bids would be opened. The date and time of opening of the Price bids would be intimated in advance to the bidders who have qualified in the Technical Bid evaluation, and their authorized representatives only would be permitted to participate in the opening of the Price bids.
- ii. Price bids should be submitted strictly as per the format given at Annexure 5 only.
- iii. L-1 BIDDER WILL BE DECIDED BASED ON BELOW CALCULATIONS:

12. Arbitration

Tender for Appointment of Sales and Marketing Consultant/ Agency for MRO services in Bangladesh.



Any dispute arising between the parties in respect of the construction, interpretation, application, meaning, scope, operation or effect of this document or the validity or breach thereof, shall first be settled by mutual consultation. If the dispute remains unresolved after a period of 90 days from the date when the mutual consultation has started, the matter shall be referred for settlement to Arbitration and Conciliation Act, 1996 of Govt. of India, and the award made in pursuance thereof shall be binding on the parties.

13. Jurisdiction

Any dispute whatsoever shall be subject to the jurisdiction of the High Courts of Mumbai, India only.

ANNEXURE - 2

SCOPE OF WORK

A. TECHNICAL:

- 1. To market AIESL's MRO Services in Bangladesh. For AIESL capabilities please refer AIESL websitehttps://www.aiesl.in/
- 2. To visit the Customers to explore the opportunities to undertake MRO Services and shall provide written visit reports on regular basis to AIESL suggesting actions to be taken.
- 3. To arrange introductions into key personnel within the targeted organizations and set-up meeting venues to discuss and Introduce AIESL Capabilities.
- 4. To prepare or assist in the preparing presentations about AIESL Services to the Customers;
- 5. As directed by AIESL, escort and introduce AIESL at all levels within targeted organizations;
- 6. Inform AIESL of any difficulties with the Customers and assist AIESL in resolving such difficulties arising out of the Services furnished by AIESL, (including but not limited to invoice queries);
- 7. Assist AIESL in obtaining prevailing competitive market rates for providing MRO Services in Bangladesh.
- 8. Assist AIESL in recovering the dues to AIESL from the customers.
- 9. Assist AIESL in getting Spares Support business.

B. REGULATORY REQUIREMENT

- Currently, AIESL MRO is approved by DGCA, India, EASA, FAA and in the process of getting Civil Aviation Authority of Bangladesh (CAAB), approval for undertaking MRO business in Bangladesh.
- The bidder should assist AIESL in securing necessary approvals with CAAB, Bangladesh Airports Management Company, Chamber of Commerce and Industries, Ministry of Manpower, Ministry of Foreign Affairs and Ministry of Transport and Communications and any other authorities in Bangladesh.
- Bidder should assist AIESL in obtaining Airport Entry Pass (AEP) and VISA for AIESL's staff at AIESL's cost.

C. MISCELLANEOUS REQUIREMENT

The bidder should assist AIESL including but not limited to following Miscellaneous Requirements at AIESL's Cost:

- 1. Bidder should assist AIESL in hiring of local staff on contract basis (if required).
- 2. Bidder should assist AIESL in hiring apron vehicle.
- 3. Bidder should facilitate to secure accommodation for AIESL's staff.
