AI Engineering Services Ltd. is an Aviation MRO and fully owned Company of Government of India which provides maintenance, repair and related support for fleets of aircraft of Govt. organizations as well as commercial domestic and international airlines.

This RFQ is issued to invite proposals from reputed Service Providers with credible experience in Annual Maintenance Contract (AMC) for Pneumatic Screw Compressors of State/Central Government department, State/Central Govt. PSUs, hospitality industry or large public organizations in conformance of specifications given in the tender documents and distribute the same at various locations in India as per requirement and schedule.



General Terms & Conditions:

Quotations are invited for the **Annual Maintenance Contract (AMC)** of **Atlas Copco make Pneumatic Screw Compressors**, installed at **JEOP, AI Engineering Services Limited**, IGI Airport, New Delhi through OEM or OEM approved service providers.

Interested and eligible vendors are requested to **submit their quotations in single packet format exclusively through the Government e-Marketplace (GeM) portal** in accordance with the terms and conditions specified.

1. You are requested to submit your lowest quotations as applicable to Government Department/Public Sector Undertaking & Government Hospitals/Institutions and also advise MRP.
2. Duly filled quotations should be submitted in GEM within the stipulated time.
3. Rates should be quoted strictly **as per the Commercial Bid Format (Annexure 6)**.
4. The Tenderer shall ensure that no damage is caused to AIESL property/ or any decorative structure/ fittings, while carrying out the work. The Tenderer will have to rectify/ make good such damages at their cost.
5. Service Provider has to arrange safety/ protective equipment at its own cost.
6. The **Purchase Order (PO)** will be placed on the basis of the **lowest quotation received**, meeting all the specified terms and conditions.
7. Payment Terms: Payment shall be released **within 30 days** from the date of **receipt of the invoice**, subject to satisfactory performance and compliance with all terms.
8. EMD (Earnest Money Deposit): - **Nil**, No EMD is required for this tender.
9. Statutory deductions such as **Income Tax** and other applicable taxes shall be **deducted at source** from each payment made to the Tenderer, as per prevailing government rules.
10. Validity: - Your quoted rates must remain **valid for a period of 120 days from the date of closing for submission of the bid**.
11. Extension of closing date / due date / time of Tender: The date / time for submission of Bids, may be extended at any time, at the sole discretion of AIESL.
12. Grounds for Rejection of Bids:
 - a) Bids should be **neatly presented**. Any corrections must be **duly authenticated** with the full signature of the authorized signatory; otherwise, the bid will be rejected.
 - b) All relevant **supporting documents** attached with the bids must be **duly signed** by the bidder. Incomplete documentation may lead to rejection.
 - c) Bids **not signed by the authorized signatory** will be rejected.
 - d) Bids submitted via **email will not be accepted**.
 - e) **Unsigned or incomplete** Technical and/or Commercial Bids will be rejected.

f) If either the **Technical Bid or Commercial Bid is not received**, the tender will be considered invalid.

g) **Conditional bids** (Technical or Commercial) will not be accepted and shall be rejected.

h) Bids **not meeting the technical eligibility criteria** specified in the tender document will be rejected during technical evaluation.

13. PENALTY CLAUSE/LIQUIDATED DAMAGES:

a) Unless otherwise notified in the tender, the penalty to be levied for delayed delivery would be @ 0.5% per week or part thereof of the value of the undelivered portion of the goods or services (excluding taxes and delivery charges) subject to a maximum of 10% of the value of the undelivered or delayed goods. This is to be recovered from the Security Deposit / Performance Guarantee, or from the amount due to the vendor after due notification to the vendor in advance.

b) The user Section should indicate in the requisition the quantum of penalty to be imposed on account of deficiencies, if any, in the delivered goods / services. The tender should incorporate the same accordingly. For those goods / services that are directly received by the users, the actual penalty to be imposed would be as per the advice of the user Section keeping in view the penalty clause of the tender and the extent of default in performance / supply.

c) There should normally be no system of waiver of LDs for delayed supplies in supply contracts and it may strictly be an exception rather than a rule. For an extension of the delivery date with waiver of LD, approval of the CA with consultation of associated Finance may be taken and justifications recorded.

14. The contractor/ successful bidder shall abide by the legal provision with regard to health, welfare and safety of persons engaged by him as per factory act and rules. The contractor/ successful bidder shall also be responsible for medical care of their personnel engaged. Ex-gratia / bonus leave salary, retrenchment benefits etc. under statutory levies shall be paid by the contractor/ successful bidder to their personnel as per bonus act / other rules at his own cost. No extra payments shall be made by AI Engineering Services Limited in this regard.

15. The contractor/ successful bidder shall be responsible for the compliance of all the rules and regulations of the following prevailing acts of Govt. of India/ Govt. of Delhi:

16.1 As per Public Procurement Policy for Micro, Small & Medium Enterprises (MSMEs) Order, 2012 issued vide Gazette Notification No. 503 dated 23.03.2012 by Ministry of

Micro, Small and Medium Enterprises of govt. of India, MSEs must be registered with any of the following in order to avail the benefits/preference available vide Public Procurement Policy MSEs Order, 2012.

- (a) District Industries Centres (DIC)
- (b) Khadi and Village Industries Commission (KVIC)
- (c) Khadi and Village Industries Board
- (d) Coir Board
- (e) National Small Industries Corporation (NSIC)
- (f) Directorate of Handicraft and Handloom
- (g) Any other body specified by Ministry of MSME

16.2 MSEs participating in the tender must submit the certificate of registration with any one of the above agencies indicating the details of the particular tendered item along with their bid.

16.3 The MSEs registered with District Industries Centers must submit the 'Acknowledgement of Entrepreneur Memorandum (EM) Part-II' along with their bid. The MSMEs registered with National Small Industries Corporation (NSIC) must submit the valid NSIC registration certificate along with their bid.

16.4 The Micro & Small Enterprises not registered for the particular trade/item for which the tender is relevant, would not be eligible for exemption/preference. The registration certificate issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.

16.5 The MSEs who have applied for registration or renewal of registration with any of the above agencies/ bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/preference.

16.6 The successful Bidder will be required to submit the Security Deposit equivalent to 5% of the Contract/PO value.

16.7 Price Preference - If an MSE bidder quotes a price within L1 + 15% of the lowest bid (L1) and L1 is a non-MSE, the MSE can match the L1 price to secure the full contract as per provision available in GEM.

16.8 Preference will be given to Start-ups as per Govt of India guidelines.

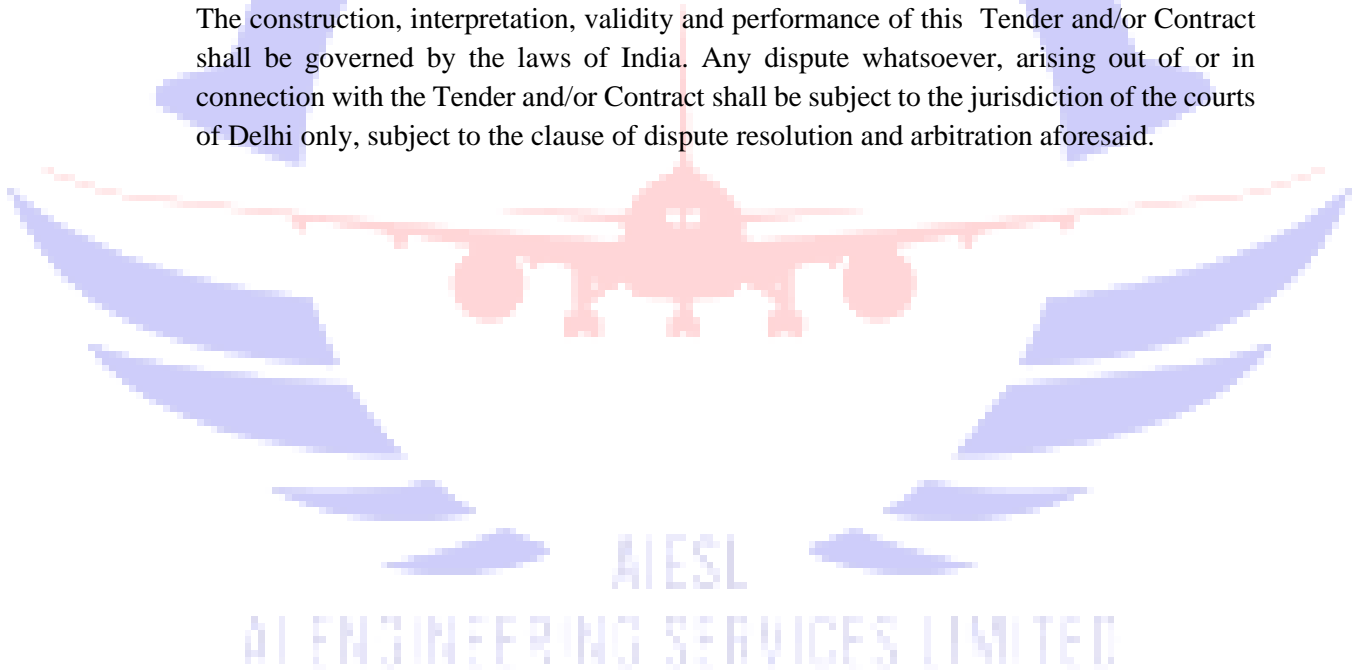
16.9 The contractor/ successful bidder shall be responsible for the compliance of all the rules and regulations of the prevailing MSE acts specified by Ministry of MSME and the changes made from time to time.

17. TERMINATION AND EXIT CLAUSES: -

The PO / contract should include a termination clause as below:

1. In case of unsatisfactory performance or breach of any of the clauses of this contract, AIESL would issue a notice of 30 days to the party to rectify the breach and improve the performance failing which AIESL shall be at liberty to terminate this agreement by providing 30 days written notice to the party. The party shall not have any right to dispute or question the judgment of AIESL of unsatisfactory performance of the party.
2. Notwithstanding the above, AIESL shall also be at liberty to terminate this agreement for any reason including change in situation/circumstances, etc. by providing to the party 90 days written notice. The party shall also be at liberty to terminate this contract by providing to AIESL 90 days written notice. In such an event, the terminated party shall have no right to claim compensation/damages, etc. from the terminating party on account of early termination. However, the party shall duly comply with their respective obligations during the notice period and thereafter, shall discharge the obligations arising out of the agreement till the termination.
3. Depending on the nature of the item / service, DGM - Engineering and above, in consultation with the user, would be the competent authority to decide the termination / exit period if it varies from the above.

- 18.** It is the responsibility of the Service Provider/bidder to ensure that they comply with all the rules and regulations legal /statutory agencies. Al Engineering Services Limited shall be indemnified from any legal action, incase of any violation by the Service Provider/bidder.
- 19.** In case of any disputes, Decision of Dy.GM (E-PPMM) will be the final and binding.
- 20.** Al Engineering Services limited, reserve the right to cancel the tender without assigning any reason. Dispute resolution and arbitration Any dispute arising between the Bidder/Successful Bidder and AIESL in respect of the construction, interpretation, application, meaning, scope, operation or effect of this document or the validity or breach thereof, shall first be settled by negotiations between the authorized representatives of the Bidder/Successful Bidder and AIESL (Parties). SCOPE OF WORK - SCREW AIR COMPRESSOR

Maintenance visit will be carried out **Twelve** times in a year for each machine during the contract period:

Schedule of Work:

1. Cleaning of Air Filter,
2. To check the oil level and oil condition and replace, if required.
3. To check and change compressor oil, Oil Separator, Filter Element etc.
4. To check and Cleaning of scavenging nozzle.
5. To check operation of thermostat.
6. To check the leakage of the system and rectify the same, if required.
7. To check operation of different valves and clean whenever required.
8. To check the leakage of the system and rectify the same, if required.
9. To tighten all the electrical connection of compressor motor.
10. To check the starter operation.
11. To check the current drawn by fan motor and main motor.
12. To check the mounting bolts of compressor and tighten, if necessary.
13. To check the noise for vibration / abnormally.
14. To check the cooling fan for proper ventilation of hot air.
15. To clean the moisture trap.
16. To grease the motor bearing.
17. To do testing of temperature switch.
18. To check the safety controls and readjust, if required.
19. To do Pressure switch setting, Tips condition checking.
20. To check Blow down valve functioning & repairing if necessary.
21. To check Control system functioning.
22. To check Coupling element condition, replace if defective.
23. To check condition of PLC / Gauges.
24. To carry out Checking of Separator or pre Separator with differential pressure gauge.(in PLC machines) if necessary.
25. To carry out Checking of panel board.
26. To carry out Checking of inventory on each visit & recommending the requirements.
27. To carry out Bearing testing with SPM.
28. To check Pressure differential against the after cooler with the help of pressure gauges, it will help to minimize the pressure drop across the cooler which will result in power saving. (Will clean it with proper chemical if necessary).
29. To check Temperature differential across the after cooler and oil cooler with the help of laser thermo gun to find out the condition of cooler. (Will clean with proper chemical if necessary).
30. Give training to operator for minor trouble shooting and scheduled services.

*NOTE: 100 hrs, 500 hrs & 1000 hrs check also to be carried out along with preventive maintenance recommended by OEM.

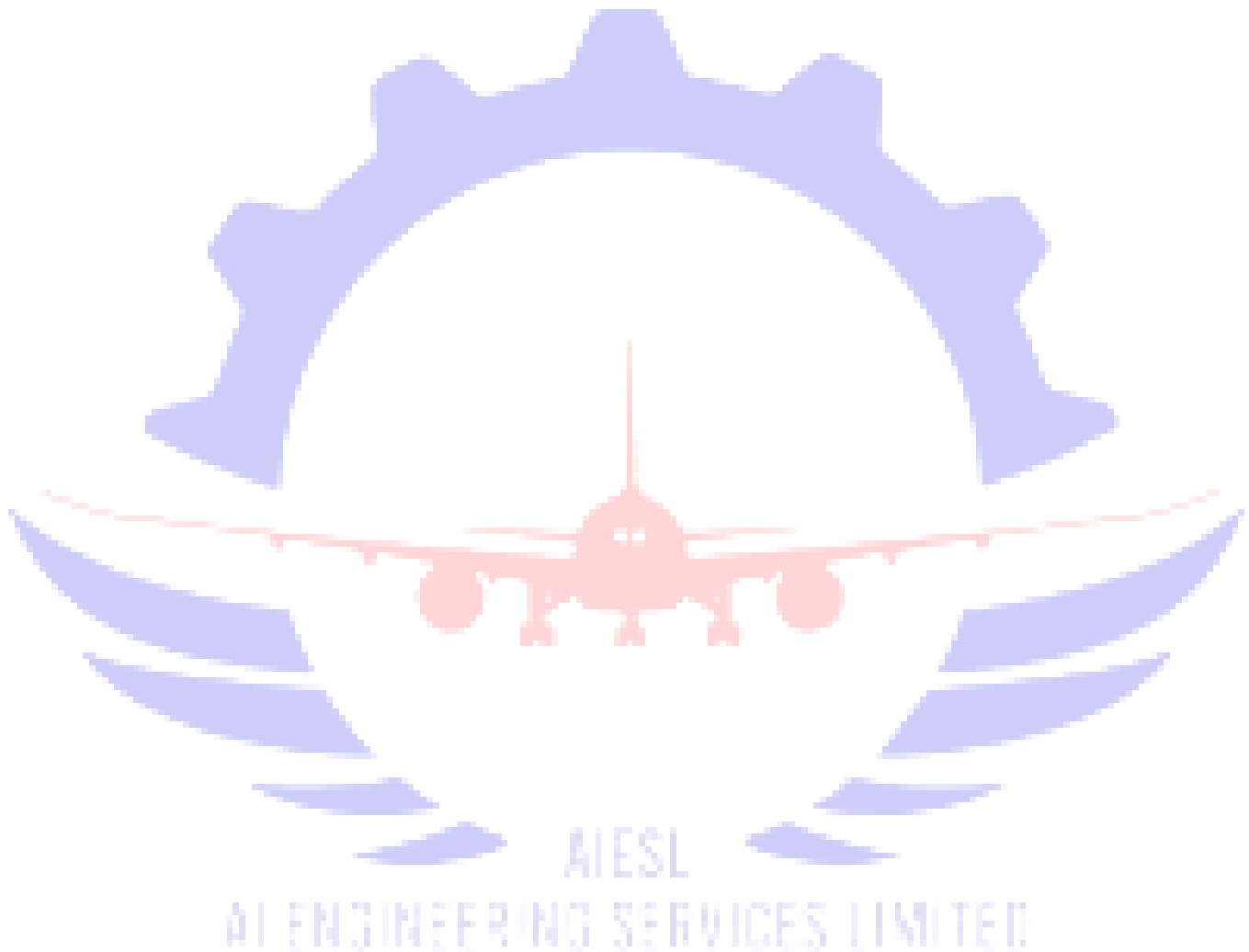

4. Cleaning agents like Cotton waste, Diesel/Kerosene and chemical solution etc. required for service purpose shall be provided by Service provider.
5. All Atlas Copco spares will be arranged by AI Engineering Services Limited as on requirement basis.
6. Service provider shall provide necessary manpower for carrying out all the repair/maintenance jobs on screw compressors under normal circumstances.
7. Service provider shall maintain the screw compressors as per prescribed maintenance schedules and document the same on all its service reports.
8. Service provider shall carry out the normal checking/repairing of the Electrical Control Panel under the AMC requiring routine repair and maintenance.
