## General Terms & Conditions:

**Quotations in Two Bid format are invited on GEM for Supply, Installation, Testing and Commissioning of two Air Circuit Breakers (ACBs) at 33kV Substation in Avionics Complex – AIESL, New Delhi.**

1. Bidder's are requested to submit your lowest quotations as applicable to Government Department/Public Sector Undertaking & Government Hospitals/Institutions and also advise MRP.
2. Duly filled quotations should be submitted on GEM within the stipulated time.
3. Rates shall be quoted as per **Commercial Bid format. (Annexure 4).**
4. The Tenderer shall ensure that no damage is caused to AIESL property/ or any decorative structure/ fittings, while carrying out the work. The Tenderer will have to rectify/ make good such damages at their cost.
5. Successful bidder has to arrange protective equipment at its own cost.
6. Purchase order will be placed on lowest quote basis.
7. Payment Terms: Payment within 30 Days credit after successful completion of work. In case Successful bidder's payment differs from AIESL Payment terms, a Bank Guarantee of Equivalent advance amount shall be furnished by the Successful bidder in the prescribed format.

9. Statutory deduction like income tax and other applicable taxes shall be deducted at source from each payment of the Tenderer.
10. Vendor must visit the site on or before the bid submission closing date to physically inspect the site.
11. Vendor must submit the site visit certificate on GEM along with the tender documents. **(Annexure 8)**

**VALIDITY:** Your rates should be valid for a period of 120 days.

**EMD:** The tenderer must deposit EMD @ Rs 12,886/- (Twelve Thousand Eight

12. Firms having valid registration with MSE/Startup are eligible for EMD exemption. Copy of Valid MSE/Startup registration certificate must be provided on GEM by the tenderer seeking exemption of EMD. **(Annexure 5)**
13. **Security Deposit:** The successful Bidder (including MSE/Startup bidder) is required to submit the security Deposit equivalent to 5% of the Contract/PO value before commencement of the work. In case, Security Deposit is not deposited in time, the bills shall not be processed for payment.
14. **Liquidated damages:** In case the Successful Bidder fails to deliver/provide the stated material as per schedule, the Successful Bidder shall become liable to pay and shall pay to AIESL by way of penalty 0.5% per week or part thereof of the undelivered portion of the goods or services (excluding taxes and delivery charges) subject to a maximum of 10% of the value of the undelivered or delayed goods. This is to be recovered from the Security Deposit / Performance Guarantee, or from the amount due to the vendor after due notification to the vendor in advance.
15. AIESL further reserves the right to terminate the Contract in the event of continued delay in providing Services and/or not meeting the quality standards as desired by AIESL, and/or any of the reasons as listed herein, and to issue a fresh Contract on any other source at the cost and risk of the Bidder.

#### 16. Grounds for Rejection of Bids

1. Vendor must ensure that the price bids and technical bids are submitted separately on GEM. Commercial bids submitted with the technical bids on GEM are liable to be rejected.
2. The Technical Bid should not contain any indication of the price. In case an indication of the price quoted is included in the Technical Bid, the quotation will be rejected without any reference to the Bidder. No correspondence will be entertained in this regard.
3. The bids should be neatly presented. Corrections, if any, should be duly authenticated with full signature of the authorized person who is signing the Tender, failing which the Tender is liable to be rejected.
4. All relevant supporting documents attached with the said bids must be duly signed by the Bidder. In case the bids are not accompanied by any and all supporting documents, the bid shall be liable to be rejected.
5. Bids received without certificate of site visit for assessment of work shall be rejected.
6. The Tender has not been signed by the authorized signatory of the Bidder.
7. If the Bid has been submitted without EMD, it will be liable to be rejected (Only MSE/startup enterprises are exempted).

17. The contractor/ successful bidder shall abide by the legal provision with regard to health, welfare and safety of persons engaged by him as per factory act and rules. The contractor/ successful bidder shall also be responsible for medical care of their personnel engaged. Ex-gratia / bonus leave salary, retrenchment benefits etc. under statutory levies shall be paid by the contractor/ successful bidder to their personnel as per bonus act / other rules at his own cost. No extra payments shall be made by AI Engineering Services Limited in this regard.
18. The contractor/ successful bidder shall be responsible for the compliance of all the rules and regulations of the following prevailing acts of Govt. of India/ Govt. of Delhi:
1. Factory Act.
  2. Minimum Wages Act.
  3. Payment of Wages Act.
  4. Bonus Act.

#### 19. Purchase Preference to MSEs:

Public Procurement Policy for MSEs Order, 2018 has been notified under section 11 of MSMED Act, 2006. It refers to the preferential treatment given to MSEs (Micro and Small Enterprises) in the procurement processes of the Government entities.

To avail Purchase Preference, Bidder(s) must adhere to specific eligibility criteria:

- **Goods:** The bidder(s) must be a manufacturer of the offered Goods or Service.
- **Services:** The bidder must be a Service provider of the offered Goods or service.

Service Provider: Bidder(s) or Service provider must be registered with the organization as mentioned in the policy or have an Udyam Registration Certificate. All MSEs must have registration as per provisions of the Policy i.e. registration with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or directorate of Handicrafts and Handlooms or Udyog Aadhaar Memorandum (UAM) or any other body specified by Ministry of MSME.

MSEs must be registered for the required Services of tender documents (providing supply and Installation/commissioning of ACB) in order to claim the exemption/preference.

The registration certificate issued from any one of the above agencies must be valid as on the close date of the tender. The Successful Bidder shall ensure that the same is valid till the end of the Contract period.

Relaxation on contract value for MSE/ Startup - 50% turnover relaxation (₹1,61,070/-) 2 years' experience, no relaxation in PO values for experience criteria.

Purchase preference shall be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 (dated 23.03.2012).

#### Matching L-1 Price:

If the Lowest Bidder (L-1) is not an MSE and in case participating MSEs are quoting price



within the price band of L1+15 (fifteen) per cent then these MSEs shall be invited to match the L-1 price. First opportunity shall be given to MSE who is quoting less than other MSEs within the price band of L1+15%. Such MSE who is able to match the L1 price shall be shall be considered for award of entire contract.

**20. Purchase Preference Policy - Make in India (PPP-MII):**

This tender comes under the purview of revised PPP-MII Order issued by Government of India, Dt. 4/6/2020 and subsequent amendments. The subject items fall under divisible category. For procedures with respect to Purchase Preference Policy (Preference to Make in India), please refer guidelines issued under PPP Policy. In order to avail preference, the bidder have to mandatorily submit declaration certificate indicating the extent of Minimum Local Content (MLC) in their product and also location of such value addition.

**Purchase preference:**

In the procurements, which are divisible in nature, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier', as per following procedure:

Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class- I local supplier', the contract for full quantity will be awarded to L1.

**21. Startup:**

Startups in the field of suppling and Installation/commissioning of ACB shall be given relaxation in past experience and annual turnover.

- Relaxation on contract value for MSE/Startup - 50% turnover relaxation (₹1,61,070/-) 2 years' experience, no relaxation in PO values for experience criteria.
- EMD Exempted.

Bidder(s) are advised to refer to the Government of India latest notice and circulars.

Startup bidder must submit a valid DPIIT certificate for availing exemption/ relaxation benefits.

Exemption from submission of Earnest Money Deposit (EMD) – The MSEs registered with above mentioned agencies/bodies are exempted from payment of Earnest Money Deposit (EMD).

The successful Bidder will however be required to submit the Security Deposit equivalent to 5% of the Contract/PO value.

22. Preference will be given to Start-ups as per Govt of India guidelines.

23. The bidder must have an average annual turnover of ₹3,22,140 /- (Three lakhs twenty two thousand one hundred forty only) or above.

24. The contractor/ successful bidder shall be responsible for the compliance of all the rules and regulations of the prevailing MSE acts specified by Ministry of MSE and the changes made from time to time.

25. As per governing guidelines, EMD is exempted for MSE and Startup enterprises. However, such bidder/s must furnish Bid Security Declaration (**Annexure- 5**)

## 26. TERMINATION AND EXIT CLAUSES :-

The PO / contract should include a termination clause as below:



- a. In case of unsatisfactory performance or breach of any of the clauses of this contract, AIESL would issue a notice of 30 days to the party to rectify the breach and improve the performance failing which AIESL shall be at liberty to terminate this agreement by providing a 30 days written notice to the party. The party shall not have any right to dispute or question the judgment of AIESL of unsatisfactory performance of the party.
- b. Notwithstanding the above, AIESL shall also be at liberty to terminate this agreement for any reason including change in situation/circumstances, etc. by providing to the party a 90 days written notice. The party shall also be at liberty to terminate this contract by providing to AIESL a 90 days written notice. In such an event, the terminated party shall have no right to claim compensation/damages, etc. from the terminating party on account of early termination. However, the party shall duly comply with their respective obligations during the notice period and thereafter, shall discharge the obligations arising out of the agreement till the termination.
- c. Depending on the nature of the item / service, DGM - Engineering and above, in consultation with the user, would be the competent authority to decide the termination / exit period if it varies from the above.

It is the responsibility of the Successful bidder/bidder to ensure that they comply with all the rules and regulations legal /statutory agencies. AI Engineering Services Limited shall be indemnified from any legal action, in case of any violation by the Successful bidder/bidder.

27. In case of any disputes, Decision of Dy.GM (E-PPMM) will be the final and binding.
28. AI Engineering Services limited, reserve the right to cancel the tender without assigning any reason. Dispute resolution and arbitration Any dispute arising between the Bidder/Successful Bidder and AIESL in respect of the construction, interpretation, application, meaning, scope, operation or effect of this document or the validity or breach thereof, shall first be settled by negotiations between the authorized representatives of the Bidder/Successful Bidder and AIESL (Parties). If the dispute remains unresolved after a period of 90 days from the date when the negotiation has started, then the unresolved dispute/difference shall be settled by arbitration in accordance with Arbitration and Conciliation Act, 1996, and the award made in pursuance thereof shall be final and binding on the Parties. The arbitral tribunal shall consist of a sole arbitrator to be mutually appointed by the Parties. The venue of arbitration shall be Delhi and the arbitration proceedings shall be carried out in English. The cost of the arbitration shall be borne by the Parties as per the award of the Sole Arbitrator
29. **Jurisdiction:** The construction, interpretation, validity and performance of this Tender and/or Contract shall be governed by the laws of India. Any dispute whatsoever, arising out of or in connection with the Tender and/or Contract shall be subject to the jurisdiction of the courts of Delhi only, subject to the clause of dispute resolution and arbitration aforesaid.
30. All other terms & conditions mentioned in the AIESL PPMM Manual are applicable to this tender.

**4. Site Survey**

A mandatory site survey shall be conducted to check panel dimensions, busbar layout, shutdown needs and verify site readiness for installation.

**5. Material Handling Equipment**

Crane/Hydra/trolley services required for unloading, shifting, and positioning of materials shall be in the vendor's scope.

**6. Safety and Site Requirements**

All necessary safety measures, PPE, barricading, and site safety protocols shall be ensured by the vendor during execution.

**7. Technical Requirement – OEM Credentials**

The bidder must be an OEM or an authorised partner of the OEM.

**Terms and Conditions: -**



1. The bidder must be an OEM (L&T/Schneider/ Siemens/ABB) or an authorised partner of the OEM from any of the three companies viz. L&T/Schneider/ Siemens/ABB. Duly attested copy of OEM authorization letter, in original, must be submitted (**MANDATORY**).
  2. The tenderer **must** visit the worksite and acquaint fully with the nature and quantum of job to be carried out, before offering price quotes. (**MANDATORY**).
  3. The party must strictly adhere to AIESL working hours i.e., from 0815 hrs to 1615 hrs.
  4. **Past Experience of similar contracts:**
    - a. The bidder must have at least **three years' experience** (ending month of March prior to the bid opening) of providing similar type of services to Central/State Government/PSUs/ Nationalized Banks/Reputed Organizations. Services rendered with list of such Central/State/ PSUs/ Nationalized Banks with duration of service shall be furnished.
    - b. The bidder must have successfully executed/completed similar Services, over the last three years i.e the current financial year and the last three years: -
      - Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost.  
Or
      - Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost.  
Or
      - One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
- Similar work shall mean works related to "Supply, Installation, Testing & Commissioning (SITC) of minimum 1000 Amperes Air Circuit Breaker of Make- L&T/Schneider/ Siemens/ABB".**
5. The work shall be carried out under the supervision of duly authorized person / class 1 license holder from the Chief Electrical Inspectorate.
  6. The party has to provide its personnel PPE's (Safety shoes, safety goggles, electrical hand gloves etc) for execution of work at the location.
  7. All tools, test equipment, required to accomplish the task shall be in the scope of bidder.
  8. Electric supply and pneumatic supply, as required to accomplish the work, shall be provided by AIESL.
  9. The site should be handed over to AIESL in a neat and clean condition. The work shall be carried out in such a manner so as to cause minimum disturbance to AIESL working.
  10. The party must submit the time schedule for completion of job and must complete the work within 30 days from the date of purchase order.
  11. Guarantee/warranty for satisfactory performance, workmanship, etc of the job carried out to be given for a period of 18/12 months i.e. (18 months from Supply and 12 months from Commissioning) & the Guarantee



of ACB Installed as provided by OEM.

12. AIESL shall not be responsible for any injury sustained to the contractor's personnel during the work at site. All risks of loss or of damage to property and of personal injury and death, which arise during and in consequence of the performance of the contract, are the responsibility of the contractor.
13. **Safety Requirements:** As a part of the Contract the Safety requirements must be satisfied & it must be ensured at all times that these are followed without deviation. The contractor will take necessary precautions to avoid any threat to human life or damage to the equipment. If any damage occurs contractor at his own cost shall make the same good.
14. The tenderer must have working office in Municipal limits of **DELHI/NCR**, in his name, as on date of the submission of the tender or else give undertaking to ensure that all local arrangements at work site i.e manpower, spare/supplies, tools etc. shall be arranged by the vendor themselves without delaying the installation/ commissioning work. Self-attested copy of Lease Agreement/Electricity Bill/ Tax receipt/ telephone bill bearing company's address in support of documentary proof of bearing working office in Municipal limits of DELHI/NCR must be enclosed.

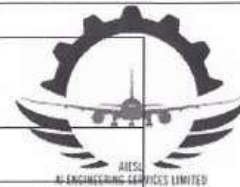

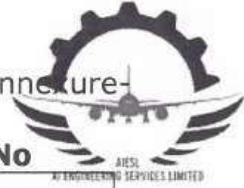
