### 1. ELIGIBILITY CRITERIA

Bidders must satisfy the following:

- NABL Accreditation:** The bidder must be a NABL-accredited testing laboratory. NABL accreditation must explicitly cover Tensile, Bend, and Metallography for the respective materials as above. Accreditation must remain valid throughout the contract, and lapse will be treated as non-compliance.
- Experience:** Minimum 2 years of experience in metallurgy or welding sample testing.
- Compliance:** Capability to perform all tests (tensile, bend, microstructure) for required materials.
- Registration:** Valid registration on GeM portal.

Delay in submission of test reports beyond the stipulated period may attract a penalty of **0.5% per week**, maximum **10% of order value**, as per GFR 2017 norms.

If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
