Scope of Work

3.2.1. Supply

The contractor/vendor shall supply the following items:

- One (1) number of **5 kVA** & one number **25 kVA Online UPS System**, true double-conversion type with IGBT-based rectifier and inverter (Make: APC / LUMINOUS / MICROTEK only).
- **Battery bank** (SMF VRLA / Li-ion/AGM) capable of providing **minimum 60 minutes backup at full load (25 kVA)** & 30 Min battery backup for 5 KVA.
- **Battery rack** (MS powder-coated) suitable for indoor installation.
- **Input and output power cables**, interconnecting DC cables and control cables.
- **MCCBs / MCBs**, fuses, lugs and other electrical protection accessories.
- **Maintenance bypass switch** (manual/automatic).
- **Monitoring accessories**, communication interface (RS-232/SNMP/USB//Modbus) and software (if applicable).
- **Copper Jumpers with Lugs with suitable nut and bolts, power cables, colour codes, terminal.**

3.2.2 Installation

The vendor shall:

- Inspect and prepare the site for UPS and battery installation.
