INTRODUCTION AND GENERAL DETAILS

1. INTRODUCTION

AI Engineering Services Limited hereinafter referred to as AIESL, is an MRO fully owned by the Government of India under administrative control of Ministry of Civil Aviation, New Delhi with the brand "AIESL" which Maintains, Repairs & Overhauls different configuration of Boeing, Airbus and ATR aircrafts, and has major operations & maintenance bases at Delhi/Mumbai/ Kolkata/ Hyderabad/ Nagpur(SEZ)/Bangaluru & Kochin.

2. PURPOSE OF TENDER

AIESL intends to appoint a service provider for exporting the Aircraft parts from India (Delhi/Mumbai/ Kolkata/ Hyderabad/ Nagpur, Bangaluru & Kochin) to overseas vendors on **door to door** basis and import/ re-import to India at Delhi/Mumbai/ Kolkata/ Hyderabad/ Nagpur(SEZ)/Bangaluru & Kochin on **door to port basis** as per the work scope / tasks as detailed in the table at Annexure – B. The work-scope shall also include shipment of aircraft parts, AOG COMAT shipments that would need to be moved one way only, based on the exigencies conveyed by the Indian offices of AIESL. The estimated Value of the required service is ₹ 7.68 crores which may vary depending upon actual volume of shipments.

GENERAL TERMS & CONDITIONS

A) Commercial Terms

1. Terms of Tender

- a) Only the IATA or FIATA approved Air International courier agencies / Air Cargo handling agencies (who have global presence across various continents and providing integrated services of end to end supply chain services on door delivery basis and meeting the eligibility criteria stated at Annexure C, are eligible to apply against this tender.
- b) Tenderers must submit their technical and price bids digitally through GeM portal only.
- c) Tenders received through fax, courier, postal and / or through e-mail will not be considered.
- d) Tenders that are incomplete are liable to be rejected.
- e) Scanned copy of the Tenders should be duly signed and stamped on every page by an authorized signatory of the tenderer and uploaded in the GeM.
- f) The price quoted in pdf copy should be clearly typed / written in figures and words, free from corrections or overwriting. Corrections, if any, must be authenticated by the full signature of the person who has signed the quotation. Any variation in figures and words, amount mentioned in the words will be taken. The Price Bid Annexure-E3 (Excel copy) must also be filled up on line in GeM portal.
- g) **All Quotations should be in INR (Indian Rupees only).**
- h) Conditional discounts, if any, shall not be given any consideration for L-1 purpose.
- i) **AI ENGINEERING SERVICES LTD** reserves the right to reject in whole or part any bid without assigning any reason whatsoever.
- j) The offers should be **valid for the acceptance by AI ENGINEERING SERVICES LTD for a minimum period of 120 days** from the date of closing of the tender.
- k) **All information related to the price to be quoted by the tenderer should be given only in the format of price bid provided in the tender.**

- ii) **The Technical Bid should not contain any indication of the price. In case an indication of the price quoted is included in the technical bid, the quotation will be rejected without any reference to the tenderer. No correspondence will be entertained in this regard.**
 - iii) The bids should be neatly presented. Corrections, if any, should be duly authenticated with full signature of the person who has signed the tender, failing which the tender is liable to be rejected.
 - iv) AI ENGINEERING SERVICES LTD reserves the right to accept / reject / defer any / all offers without assigning any reason.
 - v) The price bids of only those tenderers, who are found qualified in the Technical Bid evaluation, would be opened at a later date, which would be notified in advance to the successful tenderers by e-mail / fax.
 - vi) In the event of default, AI ENGINEERING SERVICES LTD reserves the right to claim damages from the successful tenderer. In the event of continued default, AI ENGINEERING SERVICES LTD also reserves the right to award the contract to any other party at the cost and risk of the successful tenderer. 2. Earnest Money Deposit (hereinafter referred to as “EMD”)

- (h) EMD in the case of unsuccessful bidders will be refunded to them without any interest, within 2 (two) months of award of the contract to the successful bidder. The refund of EMD shall be in the form of an account payee cheque, bank draft or wire transfer in favour of the unsuccessful bidders. Complete bank details may be provided for refund of EMD.
 - (i) EMD will be forfeited as pre-estimated damages without prejudice to any other right or remedy that may be available to AIESL under the Tender or the Agreement or otherwise, under any of the following circumstances-
 - (i) in the event of an applicant/bidder withdrawing or modifying his Bid after opening of the Commercial Bid and till completion of the tender process, i.e. till the signing of Agreement, and / or
 - (ii) in the event of the applicant/bidder, who has been selected for Agreement, declining to honor the same or to furnish the Security Deposit or Performance Bank Guarantee.
 - (iii) In case the successful bidder, having signed the Agreement, commits any breach thereof prior to furnishing the Security Deposit or the Performance Bank Guarantee.

3. Security Deposit & Performance Guarantee

The successful tenderer will have to deposit with AI ENGINEERING SERVICES LTD within 30 days of award of the contract, an amount equivalent to 5% of the PO/contract Value, towards Security Deposit / Performance Bank Guarantee. The Security Deposit is to be paid by a Bank Draft, Banker's Cheque or wire transfer in favour of AI Engineering Services Ltd, payable at New Delhi, or by execution of a Bank Guarantee for an equivalent amount. The expenses incurred towards submission of Security Deposit / Bank Guarantee will have to be borne by the tenderers.

The Security deposit / Performance Bank Guarantee will be retained up to three months after the expiry of the contract and would be refunded / returned to the tenderer within two months thereafter subject to satisfactory performance during this period, and after adjustment for liquidated damages/ penalties, if any, arising out of the non-execution of the terms and conditions of the contract.

The Security Deposit / Performance Bank Guarantee will not carry any interest.

4. Grounds for Rejection of bids

The bids are liable to be rejected forthwith, i.e., without being evaluated, on the following grounds:

- (a) If the bid has been received after the closing date / time of the tender.
- (b) If only the Technical bid has been received and the Commercial bid has not been received, and vice versa.
- (c) If the bid has been received by any form other than provisions of GeM.
- (d) If the bid has not been signed by the authorized signatory of the tenderer.
- (e) If the technical bid has been received without EMD, or proof of wire transfer (in the case of remittance by wire transfer), or the EMD has been submitted in a mode other than as specified in the tender.

5. Certification

The Tenderers are required to provide certification / undertaking with their Technical and Price bids as per the formats given at Annexures D-1 and E-1 respectively. The covering letters duly signed are to be enclosed along with the respective bids.

6. Award of Contract / Agreement & tenure

A contract / agreement will be signed between AI ENGINEERING SERVICES LTD and the successful tenderer based on the work scope & the contract terms and conditions that would be finalized with the successful tenderer. The draft contract

will be submitted by the tenderer following the issue of a Letter of Acceptance (LOA) by AI ENGINEERING SERVICES LTD, and the contract to be finalized and signed within 30 to 45 days from signing of LOA after due vetting of the draft by AI ENGINEERING SERVICES LTD.

The period of the proposed contract would be 2 years, duly extendable for another 1 year, in yearly increments, at the same rates, terms and conditions.

7. Price Negotiation

As it is not the general norm for AI ENGINEERING SERVICES LTD to carry out price negotiations with other than the most competitive bidder, the tenderers are advised to submit their best quotes in the very first response to this tender. AI ENGINEERING SERVICES LTD, however, reserves the right to carry out negotiations with the tenderer who has been evaluated by AI ENGINEERING SERVICES LTD, as having offered the lowest bid in response to the tender.

8. Delivery & support location

The successful tenderer, who has been awarded the contract, shall support all the locations of AI ENGINEERING SERVICES LTD within India, for the stated / contracted work scope as required by AI ENGINEERING SERVICES LTD. For this purpose, service provider has to designate a nodal person in India to provide support and feedback on the movement of shipments and to answer the queries of AIESL officials. Similarly, a dedicated nodal person will be required at each overseas station for logistic support.

9. Insurance

The liability of loss in transit lies on the carrier under provisions of Warsaw Convention at the rate fixed from time to time. The claim of loss / damages under transit claim are settled under the above provisions. Such settlements will be resolved as per effective provisions of Warsaw Convention.

10. Payment Terms

- a) The payment would be made on a monthly basis, under the 60 days credit terms basis by the respective stations i.e. Delhi/Mumbai/Kolkata and Hyderabad.
- b) The copies of documents viz: MAWB, HAWB, Invoice, Manifest, POD, etc. must be submitted to the PPMMD office at the respective stations i.e. Delhi/Mumbai/ Kolkata/ Hyderabad/ Nagpur(SEZ)/Bangaluru & Kochin for certification and payments.

11. Mode of Payment

Payment will be made from the respective stations i.e. Delhi/ Mumbai/ Kolkata/ Hyderabad/ Nagpur(SEZ)/Bangaluru & Kochin through online Transfers after deducting applicable taxes, as per local laws.

12. Exit Clause/ Termination Clause

- a. In case of unsatisfactory performance or breach of any of the clause of the contract, AIESL would issue a notice of 30 days to the service provider to rectify the breach and improve the performance failing which AIESL shall be at liberty to terminate the agreement by providing 30 days written notice to the service provider. The service provider shall not have any right to dispute or question the judgment of AIESL of unsatisfactory performance of the service provider.
- b. Notwithstanding the above, AIESL shall also be at liberty to terminate the agreement for any reason including change in the requirement / circumstances, etc. by providing the service provider a 90 days written notice.

- c. The Successful Bidder shall have a right to terminate this Agreement by giving a 90 days advance notice to AIESL, of its reasons for termination. In such an event, the terminated party shall have no right to claim compensation / damages etc. from AIESL on account of early termination. During this period of three months, AIESL and the Successful Bidder, may initiate discussions for purpose of resolution of the said reasons. In the event a resolution is achieved by AIESL and the Successful Bidder, the Contract shall not be terminated and the Successful Bidder shall provide the Services, in the same manner, as it was providing prior to such notice of termination. For the avoidance of any doubt it is hereby clarified, that the Successful Bidder during the aforesaid notice period shall continue to provide the Services, till the termination, in the same manner, as it was providing prior to such notice of termination.
- d. The tenderer opting for termination as per clause " c " above, will not be eligible to participate in the immediate next tender or five years whichever is earlier.

13. Arbitration

Any dispute arising between the parties in respect of the construction, interpretation, application, meaning, scope, operation or effect of this document, or the validity or breach thereof, shall first be settled by mutual consultation. If the dispute remains unresolved after a period of 90 days from the date when the mutual consultation has started, the matter shall be referred for settlement to the 'SCOPE FORUM OF CONCILIATION AND ARBITRATION', Govt. of India, and the award made in pursuance thereof shall be binding on the parties. Any other mode / methodology of arbitration will be done with mutual consent / acceptance.

14. Jurisdiction

Any dispute what-so ever, shall be subject to the jurisdiction of the courts of New Delhi only. Any other jurisdiction will be as agreed upon with mutual consent/ acceptance.

15. Inspection

AI ENGINEERING SERVICES LTD reserves the right to inspect, the tenderers facilities anytime during the evaluation stage and prior to the signing and execution of a contract.

16. Validity of Price

The price quoted and agreed rates must remain firm during the contract period. No request for increase in price shall be entertained during the period of validity of the contract.

a. Inclusions:

The quoted rates will include EXW charges, Customs Charges, Administrative charges, Inland Freight, port charges/handling charges, Warehouse charges etc. at Port of Origin/Port of Discharge, Air Freight, Fuel Surcharges, Security Surcharges, DO Fee (Airlines DO, Agent DO, Documentation Charges, etc.).

b. Exclusions:

Customs Duty, Merchandise Processing Fee, Green Charges, other charges/taxes levied by Govt authorities or statutory charges/surcharges will be paid as per actual on submission of original/certified copies of supporting bills.

17. Penalty Clause:

- (a) For regular shipments items penalty shall be levied for the delayed delivery @ 0.5 % per week subject to a maximum of 10% of the total value of one way freight charge to the concerned destination.
- (b) Penalty shall not be applicable if delay is on account of reasons enumerated in clause 8(c) of work scope and also if it is due to operational issues involving AIESL.

- (c) Pickup of all AOG shipments will have to be done within 24 hours and to be booked by first available flight. In case of any delay in shipments of AOG items 10% of freight charge shall be deducted (*applicable for tenderers who quoted for AOG rates*).

18. Amendment

Amendments, corrigendum, clarifications and due date extension if any, to this Tender will be hosted on the Gem portal only, no separate Notice Inviting Tender (NIT) would be issued in the newspapers or anywhere else. AIESL will also not intimate the Bidders individually of the same. The Bidders are therefore, advised to visit the Gem Portal regularly till the date of closing of the Tender (or extended date, if any). The last amendment, if any, will be hosted a minimum of seven (07) days before the closing date of the Tender.

19. Modification of Bids

- a. On account of any amendments, being made to the Tender the Bidders shall have a right to modify their bid after the bid submission but prior to the due date (or extended due date, if any) for submission of Bid. The guidelines of GeM, in this regard will be followed. The last modified bid of the Bidder before the due date (or extended due date, if any) shall be final and binding on the Bidder.
- b. At any time prior to the last date for submission of bids, AIESL may for any reason, whether at its own initiative or in response to a clarification requested by a prospective Tenderer, modify this Tender document by an amendment. In order to afford reasonable time to Tenderers to take such amendments into account for preparation and submission of their bids, AIESL may, at its discretion, extend the last date for the submission of bids through an announcement of its website.

20. Withdrawal of Bids

No bid will be permitted to withdraw in the interval between the last date for submission of bids and expiration of the period of bid validity. Withdrawal of bid during this period would result in forfeiture of bidder's EMD. However, on account of any amendments by AIESL, the Bidder may withdraw their bid after the bid submission prior to the due date (or extended due date, if any) for submission of bid.

21. Award of the Contract, Acceptance and Commencement:

- a. The Contract shall be awarded to the Successful Bidder vide the Letter of Acceptance (LOA) issued by AIESL, based on the evaluation of the bids by AIESL.
- b. The Successful Bidder has to convey acceptance of the LOA within 7 days of its receipt.
- c. The successful bidder must execute an agreement with AIESL on a non judicial stamp paper of ₹ 100/- (Rupees One Hundred) within 02 (Two) weeks from the date of acceptance of LOA.

22. Zero deviation:

Bidders are advised to quote strictly as per terms and conditions of tender document and not to stipulate any deviation / exceptions.

23. Service Delivery:

- 23.1 The Successful Bidder should start providing the services mentioned in the Tender immediately from the date of the Letter of Award (LOA).
- 23.2 The Bidders who submit their Bid are deemed to have agreed to comply with all the conditions of this Tender including the commencement of services within the period mentioned aforesaid.

24. Price, Contract Validity and Extension:

The validity of the Contract would be from the date of LOA and the term of the proposed contract shall be 2 years, unless terminated earlier as per the terms and conditions of the Contract. However, if mutually agreed, the contract may be extended by AIESL for a further period of 1year under the same Terms & Conditions.

The prices shall remain constant for the entire tenure of the contract of 2 (two) years and for further 1 year if period of contract is extended as para above. No request for increase in price shall be entertained during the validity period of the contract.

Increase in government duties/taxes/levies or introduction of any new taxes by the government during the period of the Contract, the same may be borne by AIESL if mandated by law and requested by the Successful Bidder. 27. RECOVERY OF SUM DUE:

Non restoration of such Security Deposit will be treated as event of default, leading to right of AIESL to take appropriate remedial action, including termination of the contract.

28. CONFIDENTIALITY:

Confidential information means information that is designated as 'confidential' or which by its nature is clearly confidential.
- b. The Bidder/Successful Bidder/AIESL shall not disclose the confidential information to any other third party, without the prior written consent of each other, or required to be disclosed at law.
- c. However, they may be entitled or bound to disclose such Confidential Information under compulsion of law and to comply with applicable laws or under a valid order of a competent court where requested by governmental or regulatory agencies or to their professional advisers where reasonably necessary for the performance of their professional services.
- d. As such, the Bidder/Successful Bidder/AIESL agree to keep such Confidential Information as strictly confidential and shall disclose the same to their employees/professional advisers only on a 'need to know' basis.
- e. The Bidder/Successful Bidder/AIESL agree that any such information received by it shall be:

29. CONTRACT SURVIVABILITY:

In the event the Successful Bidder is acquired by, or merges with another company/entity/organization by operation of law or in any other manner, the terms and conditions of the Tender/Contract applicable to the Successful Bidder shall remain in full force and effect on the new entity and the Successful Bidder shall at all times remain liable to AIESL, with regard to the obligations mentioned herein. AIESL shall, however, have the discretion and option to terminate the Contract in such an event.

30. CONTRACT SEVERABILITY:

If any clause, section, or provision of this Contract is found to be invalid, illegal, or unenforceable, by the provisions of the applicable law, such invalidity, illegality, or unenforceability shall not render the remaining clauses, sections, or provisions hereof invalid, illegal, or unenforceable. In such a case, the Parties shall amend this Contract as appropriate, seeking to achieve the minimum extent necessary to make this Contract, legal valid and enforceable.

31. COMPLIANCES WITH THE APPLICABLE LAWS:

The Successful Bidder shall comply with all laws in force in India and in force in the countries from where the materials is imported or exported and comply with all the laws whether prevailing in India or elsewhere with regard to the Services as mentioned in this Tender. The laws will include all national, provincial, municipal, or

other laws that affect the performance of the contract and are binding upon the Successful Bidder. The liabilities of all statutory /legal mandatory regulations /obligations regarding manpower / product / services will be borne by the Successful Bidder. The Successful Bidder should indemnify AIESL from any breach of any government regulation/infringement of laws- such as copyright act, trademark act, PF regulation, ESI regulation, Labour laws, Minimum wages act, etc, more particularly as mentioned in the clause herein below.

32. INDEMNIFICATION:

- 32.1 The Successful Bidder shall indemnify AIESL against the payment of penalty/third party claims/damages/loss of property of AIESL, its subsidiaries or any other party arising due to the negligence on part of the Successful Bidder and/or its employees.

- 33.1 The Bidder/Successful Bidder/AIESL (herein referred Party/Parties) shall not be liable for, nor be in default by reason of any failure or delay in discharge of its obligations under this Tender/Contract, where such failure or delay is caused by any act, including but not limited to any act of God, action or inaction of government authorities, fire, flood, gales, storm, lightning, earthquake, explosions or other catastrophes, accidents, weather, power failure or shortage of power, riot, war declared or undeclared), warlike operations, act of terrorism, boycott, embargo, rebellions, sabotage, epidemics, quarantines, lock out, restrictions on travel based on travel advisories of any governmental entity, unavailability of the usual means of transportation, hostilities, revolution, civil commotion or public disorder or any other cause beyond its control.
- 33.2 The Party encountering and affected by such causes and event shall inform the other in writing immediately of such an occurrence event and will shall use its best reasonable efforts to minimize the economic and other effects and rectify as soon as possible any harm or delay created thereby shall reasonably allocate its available resources, giving priority to their obligations under this Tender/Contract.
- 33.3 For the avoidance of any doubt it is clarified that, payment obligations of AIESL shall be excused due to an

event of Force Majeure.

34. EXEMPTION OF EMD:

- ii. MSEs participating in the tender must submit the certificate of registration with any one of the above agencies indicating the details of the tendered item along with their bid.
