If firm/contractor continues to fail to provide the work for more than one week at a stretch, besides deduction of the payment, the contractor shall be liable to pay the liquidated damage (LD)/penalty charges at the rate 0.5 % (half percent) of the total cost of the work in accordance with per week beyond such time frame subject to a maximum of 10% (Ten percent) of the total cost of work and The EMD and Performance Security will be forefitted.
- There should normally be no system of waiver of LDs for delayed supplies in supply contracts and it may strictly be an exception rather than a rule. For an extension of the delivery date with waiver of LD, approval of the CA with consultation of associated Finance may be taken and justifications recorded.


