A. Annexure-II, Scope of work, Clause no-4 :

“Providing pre-employment health check-up.”

Please read as:

The vendor must also have provisions for pre - employment medical check - up. A typical set of tests for pre - employment would include the following:

- i) Blood group determination
- ii) FBS
- iii) Urine (RE)
- iv) X Ray (chest PA view)
- v) Audiometry
- vi) ECG
- vii) Eye test - including vision and colour blindness
- viii) Blood - TLC, DLC, ESR, HB%.

However, expenses for these tests will be borne by the candidates themselves.

“Providing annual health check-ups for approximately 600 employees.”

Providing annual health check-ups for approximately 600 employees. The list of medical tests to be conducted by the prospective vendor during the annual health check up program are:

- a) CBC
- b) Glucose (random)
- c) Lipid Profile
- d) LFT
- e) Creatinine
- f) Urea
- g) ECG
