 My name is Tulika Prasad,my husband late sh. Suraj Prasad worked for Air India (engineering department). He was a permanemt emplyee since 1990.
 Sir he was the sole earning member in our family and his sudden on duty death has left us appalled and without any support at all. I along with my two children were wholly dependent on him and have found it imposible to be able to keep our heads above the water after his sudden on duty death on 8/7/2020. I hence applied for a permanet job on compassionate grounds at air india but all my application requests for it went unheard or I received a very vague and blur reply , and as I have no source of income since last 6 months , it is imposible for me to be able to even arrange for very basic need for me and my family like groceries , education,bills etc .

My request to you through this RTI is that please send me or disclose it on your website the provisions /principles / policy brochure or any written document that clearly specifies the provision of compassionate appointments at Air India .
