3.2 Technical Eligibility Criteria

- 1. The floor must first of all withstand the weight of the aircraft which is approximate 100 ton planes.
- 2. The floor is exposed to chemical compounds contained in materials such as aviation fuel, hydraulic fluids (eg. Skydrol) or lubricants. Therefore Hangar floor must be resistant to both the short and long term effects of exposure to all the various chemicals that will be used onsite.
- 3. Typical system consists of a high performance epoxy primer followed by underlay of epoxy coat followed by urethane coat

- 2. The Service Provider shall abide by all safety regulations laid down by AIESL from time to time and shall not follow any unsafe practices.
- 3. The service provider shall also provide another staff in case any of his staff positioned at site goes on leave/weekly off.
- 4. The service provider should agree to depute staff capable of reading, writing and understanding Hindi & English language. - 19. Personnel engaged by the Service Provider must be properly attired for achieving a smart turnout and to meet the standards necessary for the job. 
